1. Introduction

Welcome to ReviewNB Technologies Pvt Ltd.

- ReviewNB Technologies Pvt Ltd ("us", "we", or "our") operates https://www.reviewnb.com/ (hereinafter referred to as "**Service**").
- Our Privacy Policy governs your visit to https://app.reviewnb.com/, and explains how we collect, safeguard and disclose information that results from your use of our Service.
- By using Service, you agree to the collection and use of information in accordance with this policy.

 Unless otherwise defined in this Privacy Policy, the terms used in this Privacy Policy have the same meanings as in our Terms and Conditions.
- Our Terms and Conditions ("**Terms**") govern all use of our Service and together with the Privacy Policy constitutes your agreement with us ("**agreement**").

2. Definitions

- **SERVICE** means the https://app.reviewnb.com/ websites operated by ReviewNB Technologies Pvt Ltd.
- **PERSONAL DATA** means data about a living individual who can be identified from that data (or from those and other information either in our possession or likely to come into our possession).
- **USAGE DATA** is data collected automatically either generated by the use of Service or from Service infrastructure itself (for example, which ReviewNB page you visited at what time).
- **SERVICE RELATED DATA** is data collected as part of your usage of the service.
- **COOKIES** are small files stored on your device (computer or mobile device).
- **DATA CONTROLLER** means a natural or legal person who (either alone or jointly or in common with other persons) determines the purposes for which and the manner in which any personal data are, or are to be, processed. For the purpose of this Privacy Policy, we are a Data Controller of your data.
- **DATA PROCESSORS (OR SERVICE PROVIDERS)** means any natural or legal person who processes the data on behalf of the Data Controller. We may use the services of various Service Providers in order to process your data more effectively.

DATA SUBJECT is any living individual who is the subject of Personal Data.

THE USER is the individual using our Service. The User corresponds to the Data Subject, who is the subject of Personal Data.

3. Information Collection and Use

We collect several different types of information for various purposes to provide and improve our service to you. Details present in sections below.

4. Types of Data Collected

Personal Data

While using our Service, we may store personally identifiable information that can be used to contact or identify you ("**Personal Data**"). Personally identifiable information may include, but is not limited to:

- (a) Email address
- (b) Your GitHub profile information GitHub handle, GitHub id, GitHub avatar and GitHub access token to make API calls to GitHub

We may use your Personal Data to contact you with newsletters, marketing or promotional materials and other information that may be of interest to you. You may opt out of receiving any, or all, of these communications from us by following the unsubscribe link or by emailing at support@reviewnb.com.

Usage Data

We may also collect information that your browser sends whenever you visit our Service or when you access Service by or through a mobile device ("**Usage Data**").

This Usage Data may include information such as which ReviewNB page you visited, at what time, repository name, commit id, pull request number and if you took any actions on ReviewNB web page (such as posting comments).

We use third party services (Sentry) for capturing errors and in case of errors they may store information such as your Internet Protocol address (e.g. IP address), device & browser information, the pages of our Service that you visit, the time and date of your visit and other diagnostic data.

Service Related Data

We collect information that is required for operation, maintenance, enhancement of the service ("Service Related Data").

This Usage Data may include

• Comments you write on the service

- GitHub Metadata including but not limited to repository name, repository owner login, GitHub account id, repository visibility status (public/private), repository id, commit oid, branch name, file path, file name, file sha, pull number
- We do NOT store actual repository contents. In other words all files in your repository stays with GitHub. Any time you visit a page on ReviewNB that requires an access to repository contents, we make API calls to GitHub, process the content & serve it to you in real time.

Use of Data

ReviewNB Technologies Pvt Ltd uses the collected data for various purposes:

- (a) to provide and maintain our Service;
- (b) to notify you about changes to our Service;
- (c) to allow you to participate in interactive features of our Service when you choose to do so;
- (d) to provide customer support;
- (e) to gather analysis or valuable information so that we can improve our Service;
- (f) to monitor the usage of our Service;
- (g) to detect, prevent and address technical issues. In some cases this includes using your GitHub access token to make API calls to GitHub on your behalf to diagnose or fix an issue.
- (h) to fulfill any other purpose for which you provide it;
- (i) to carry out our obligations and enforce our rights arising from any contracts entered into between you and us, including for billing and collection;
- (j) to provide you with notices about your account and/or subscription, including expiration and renewal notices, email-instructions, etc.;
- (k) to provide you with news, special offers and general information about other goods, services and events which we offer that are similar to those that you have already purchased or enquired about unless you have opted not to receive such information;
- (I) in any other way we may describe when you provide the information;
- (m) for any other purpose with your consent.

5. Retention of Data

We will retain your Data only for as long as is necessary for the purposes set out in this Privacy Policy. We will retain and use your Data to the extent necessary to comply with our legal obligations (for example, if we are required to retain your data to comply with applicable laws), resolve disputes, and enforce our legal agreements and policies.

6. Transfer of Data

- Your information, including Personal Data, may be transferred to and maintained on computers located outside of your state, province, country or other governmental jurisdiction where the data protection laws may differ from those of your jurisdiction.
- If you are located outside the United States and choose to provide information to us, please note that we transfer the data, including Personal Data, to the United States and process it there.
- Your consent to this Privacy Policy followed by your submission of such information represents your agreement to that transfer.
- ReviewNB Technologies Pvt Ltd will take all the steps reasonably necessary to ensure that your data is treated securely and in accordance with this Privacy Policy and no transfer of your Personal Data will take place to an organisation or a country unless there are adequate controls in place including the security of your data and other personal information.

7. Disclosure of Data

We may disclose personal information that we collect, or you provide:

(a) Disclosure for Law Enforcement.

Under certain circumstances, we may be required to disclose your Personal Data if required to do so by law or in response to valid requests by public authorities.

(b) **Business Transaction**.

If we or our subsidiaries are involved in a merger, acquisition or asset sale, your Personal Data may be transferred.

(c) Other cases. We may disclose your information also:

(i) to our subsidiaries and affiliates;

8. Security of Data
